After a discussion of possible options to address the situation, the Board expressed some interest in possibly closing the Infant room and moving the remaining staff to the preschool room. The preschool room is more cost effective and easier to staff. This would also give the daycare a final opportunity to become self-sufficient before a decision to close the entire facility. The Board directed the FVCC director to continue to keep them informed and to attend a special FVCC Board meeting on January 9, 2019 for deciding on a course of action for SWLC for FY20.
